<b>Local Indices</b>			<p><b>Amended tax laws to tighten noose on non-filers:</b> (Economy: Negative to Neutral) National Assembly Standing Committee on Finance will take up money bill, "Tax Laws (Amendment) Bill, 2024," on Tuesday and government will soon prohibit non-filers from purchasing, booking, registration of vehicles over 800cc, acquiring property beyond a specified limit, and making stock purchases beyond a certain threshold. The government will not immediately abolish higher rates of withholding taxes on non-filers after passage of the "Tax Laws (Amendment) Bill, 2024". This would be done in a phase-wise manner because there is no justification of higher WHT rates after ban on transactions of non-filers. Changes in withholding tax regime would be done in the coming budget (2025-26), officials confirmed. It is not clear how the FBR will overcome revenue shortfall after withdrawal of higher rates of WHTs, as withholding taxes constitute nearly 70 percent of overall direct taxes collection, tax experts questioned. Additionally, non-filers will not be able to open bank accounts, and there will be restrictions on the number of banking transactions they can conduct. Similarly, the trade deficit has surged by 36.5% compared to December 2023's deficit of \$1.81bn. The balance of trade figures cumulative from July – December 2024 (FY2024-25) was (-)3.11 trillion in terms of Rupees and (-)11.2bn in US dollars. ## **Overseas investors repatriate \$1.2bn in 6MFY25:** (Economy: Negative)

Foreign investors' repatriation of profit and dividends rose 114% YoY in 6MFY25 to \$1.21 billion compared to \$567.72m worth of repatriation in the same period last year, the latest data issued by the central bank revealed. The data further revealed that during the period, foreign companies repatriated \$1.15bn worth of profit against the foreign direct investments (FDI) in various businesses compared to \$521.39m in SPLY, marking an increase of around 121% YoY in 6MFY25. Meanwhile, in December 2024 alone, foreign firms' repatriation of profits and dividends stood at \$85.8m.

## **Power generation rises 1% YoY in December 2024:** (Economy: Positive)

The total power generation in the country increased by 1% to 7,800 GWh during December as compared to 7,726 GWh in the same month of last year. According to the monthly electricity generation data released by the National Electric Power Authority (NEPRA), the total power generation decreased by 3% MoM compared to 8,032 GWh in November 2024. On a cumulative basis, in 6MFY25, electricity generation stood at 66,641 GWh, down 3% YoY compared to the generation of 68,982 in 6MFY24.

## **OGDCL boosts oil output from Pasakhi-7 Well in Sindh:** (Economy: Positive) (OGDC: Positive)

Oil & Gas Development Company Limited has declared an increase in oil production from the Pasakhi-7 well, situated in District Hyderabad, Sindh. The well is part of the Pasakhi Development & Production Lease (D&PL), where OGDCL holds full ownership with a 100% working interest. As part of its optimization efforts, OGDCL deployed a rig to replace tubing and re-complete the Pasakhi-7 well using an artificial lift system (Jet Pump), the company's filing on PSX revealed today. The company also introduced Multiphysio Chemical Stimulation technology in the Southern Region. These measures boosted production at the well from 375 barrels per day (BPD) to 520 BPD, an increase of 145 BPD. OGDCL has also achieved its first-ever discovery in the Mari East Block with the exploratory Chak 212-1 well, located in Rahim Yar Khan district, Punjab
