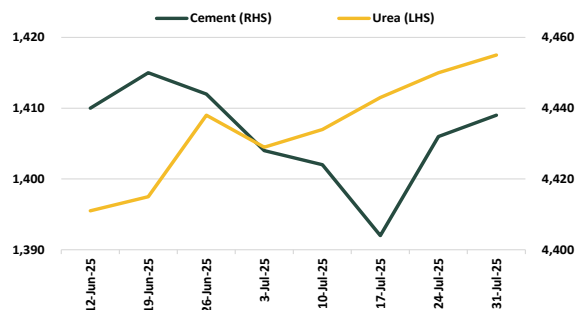

Nepra approves Rs1.89 cut in uniform tariff for Aug-Oct: (Economy: Positive)

The National Electric Power Regulatory Authority (Nepra) approved on Thursday a decrease of Rs1.89 in the uniform tariff for three months starting from August. The authority decided to allow "negative quarterly adjustments of Rs55,874 million pertaining to the 4th quarter of the FY 2024-25, in a period of 03 months i.e. August 2025 to October 2025, at a uniform rate of negative Rs1.8881/kWh, to be applicable to all consumer categories, except lifeline consumers and prepaid consumers of XWDISCOs," Nepra notification read. The quarterly adjustment is also applicable to consumers of K-Electric except life line and prepaid consumers.

Public resources programme: World Bank likely to approve \$600m: (Economy: Neutral to Positive)

The World Bank is likely to approve \$600 million for 'Pakistan Public Resources for Inclusive Development Multiphase Programmatic Approach: Phase 1 – Federal' with the objective of increasing the level and quality of spending on inclusive development. Official documents reveal that the federal government program is estimated at \$ 1,624 million over 5 years and aligned to fiscal and primary balance targets agreed under the International Monetary Fund's Extended Fund Facility (EFF) and the government's Medium Term Fiscal Framework (MTFF). Of this, the World Bank's contribution to the program will be \$600 million.

IT, IT-enabled services to face 4pc WHT: (Economy: Neutral)

The IT and IT enabled services will continue to be subject to withholding tax rate of 4 percent during 2025-26. According to an income tax circular of the Federal Board of Revenue (FBR), the withholding tax rates on non-categorized services under section (u/s 153) applicable prior to Finance Act, 2025 were applied at the rate 9 percent and 11 percent for company and other than companies respectively. The rate of withholding for Sports Person was 10 percent. Similarly, under section 152 and 153 of the Income Tax Ordinance categorized services were chargeable to withholding tax at the rate of 4 percent.

Early disposal of govt debt securities: FBR to levy 20% capital gains tax: (Economy: Negative)

The Federal Board of Revenue (FBR) will apply 20 percent tax on capital gains on early disposal of debt securities of federal government within specified period of six months. Through a income tax circular, the FBR has explained that prior to enactment of Finance Act, 2025, the capital gain arising to non-resident person having no permanent establishment in Pakistan invested through Special Convertible Rupee Account (SCRA) on debt securities of the Federal Government was charge to tax at the rate of 10% without any holding period.

CCP report: Fertilizer sector cites multiple flaws: (Economy: Neutral)

Pakistan's fertilizer sector has raised serious concerns over the recently published Competition Commission of Pakistan (CCP) report on the fertilizer industry, citing multiple analytical flaws and omissions. According to stakeholders, the report presents a narrowly framed, competition-focused evaluation that overlooks fundamental structural, strategic, and national security issues—particularly regarding natural gas allocation, which underpins the entire viability of urea production in the country. The CCP report aims to assess market dynamics and concentration within the fertilizer sector. However, the industry argues it fails to address the core challenge of natural gas allocation, which is essential for urea production. "Urea is a gas-based product—its economics, viability, and even existence depend on the allocation of indigenous gas at viable tariffs," industry representatives stated.

FBR aligns banking income with taxable income: (Economy: Neutral, Commercial Banks: Neutral to Negative)

The Federal Board of Revenue (FBR) has amended the banking schedule of the Income Tax Ordinance 2001 to align the banking income close to the taxable income from July 1, 2025. The FBR's budget explanatory circular on Finance Act 2025 stated that the FBR has introduced change in the seventh Schedule Provisions for Banking Companies Seventh Schedule. The seventh schedule has been amended to align the banking income close to the taxable income. In this regard, rental expenses and expenses on refurbishment of offices are allowed in a specified manner as laid down in the provisions.

June FCA: Nepra approves Re0.78/kWh negative adjustment: (Economy: Positive)

The National Electric Power Regulatory Authority (Nepra) has approved negative adjustment of Re 0.78/kWh in FCA of Discos to refund over Rs 11 billion to the consumers for June 2025 to be applicable for Discos jurisdiction and Rs 1.89/kWh for fourth quarter of FY 2024-25 across the country including K-Electric. Central Power Purchasing Agency-Guaranteed (CPPA-G) had sought negative adjustment of Rs 0.65/kWh. Nepra held a public hearing on July 30, 2025 to verify generation data and hear viewpoints of consumers whereas hearing on QTA was held on August 4, 2025.

Pakistan's Forex Reserves Decrease by USD 111.40 Million: (Economy: Neutral to Negative)

Pakistan's Forex Reserves decreased by USD 111.40 Million or 0.57% and the total liquid foreign reserves held by the country stood at USD 19,495.60 Million on Aug 01, 2025. According to data published by the State Bank of Pakistan (SBP) its reserves decreased by USD 72.00 Million due to external debt repayments. While net reserves held by Commercial banks decreased by USD 39.40 Million during the week.

As per the approved resolutions, HUBCO has been authorized to provide or amend guarantees in the form of Standby Letters of Credit (SBLCs) for both TEL and TN.

"By surpassing Carrefour (MAF)'s stringent quality benchmarks, TOMCL is now an approved vendor for all Carrefour (Majid Al-Futtaim -Hyper Market LLC) UAE retail networks, significantly enhancing its regional footprint and positioning the company as a trusted halal meat supplier across major Middle Eastern retail markets," TOMCL said.

Pakistan Refinery to buy its first Nigerian Bonny Light oil from Vitol: (Economy: Neutral to Positive, PRL: Positive)

Pakistan Refinery Limited will import its first cargo of Nigerian Bonny Light crude from Vitol in September, as Asian refiners shift towards cheaper alternatives to Middle Eastern oil. The 500,000-barrel, light-sweet crude cargo is expected to load later this month and arrive in Karachi by late September, declining to be named as the information is not yet public. The price was not immediately known. Vitol and PRL did not immediately respond to a request for comment.
